Pacific Electric Right of Way

The city used the information to update the basic plan. The new plans will be provided to the Belmont Heights Community Association so they can be shared and reviewed by all interested parties.

Broadway Medians

Dianne provided an update. Medians are planned for Broadway between Park and Belmont. The medians in this section of Broadway will be narrower. The city will deliver revised plans next week. The Belmont Heights Community Center will send out an email to their general email list announcing a meeting time and place for all interested parties to attend and review the revised plans.

Vista Roundabouts

Dianne announced the plans for the city to replace the existing trees, which are not doing well, in the roundabouts on Vista with larger trees and to have them planted by professionals. The Belmont Heights Community Association is asking for volunteers who live near a roundabout to adopt a circle to see that the new trees are receiving the attention they need to thrive. Thanks to those people who have already volunteered. Only three more volunteers are needed. Dianne asked that interested parties contact her.

3rd District Update

Julie Maleki from the 3rd District Council office announced that a Smart and Final grocery will be opening their doors in the structure between Redondo and Newport and 6th and 7th.

Steve Massis, Owner, The Attic Restaurant

Steve reported that his restaurant has applied for a "conditional use permit" to remodel the patio area. He intends to rebuild the bar to include seating and install a patio cover. They will not be changing their hours of operation nor expanding their food services. They want to better serve their customers, provide a safer environment and cut down on noise. He asked if anyone in the neighborhood had questions or concerns. There were some clarifying questions, but no one voiced any concerns.
